#### **RCONA Executive Reports**

<u>Approval of June 2018 Minutes</u>: Hearing no inquiries or objections, the President ordered the minutes of the June 2018 meeting accepted and placed on file.

<u>Receipt of Treasurer's Report</u>: One suggestion received to expand 6/22 PayPal transfer (Kettle Corn). With that note to be added, the President ordered the Treasurer's Report dated January 1, 2018 to July 17, 2018, placed on file as submitted.

<u>Public Comment</u>: Werner noted August's guest speaker topic: Small Cell Towers. Larry noted new location for RCONA maps on City's website needs to be connected on RCONA site.

**Guest Speakers/Presentation**: None

**7:05 PM Round Table** proceeded with abbreviated comments as follows.

A list of regular NA meeting schedules is posted on the RCONA.org website. Please contact Sue Cook before considering changes to your NA meeting schedule, and notify Police (<a href="mailto:ingrammelisa@roseville.ca.us">ingrammelisa@roseville.ca.us</a>) and Fire (<a href="mailto:igarrett@roseville.ca.us">igarrett@roseville.ca.us</a>) if you need to change an upcoming meeting night so they can notify staffing.

Updates from NA Representatives (shown above)

Roseville Police: Melisa Ingram (replacing Rob Baquera while he is interim PIO); items covered:

- Detailed crime statistics—format changing to 10-year-to-date instead of one-year-to-date reporting.
- Smash & Grab incidents—Gibson/Roseville Pkwy, Hyatt Hotel area—30-50 cars broken into. Hit & run stats up, DUI down, Traffic Division concentration on top 3 areas, including Douglas corridor and Pleasant Grove Blvd.
- Take/Lock/Hide—program to promote awareness (i.e. Galleria/hotels/restaurants).
- June to September—high time for garage burglaries—keep main and side doors closed.
- Police reports are available through Public Records Act; submit request via online form and pay applicable fee.
- Discussions for 'solicitors'—report to police non-emergency; they must have full-page color business license issued with their name on it (have to apply for City permit first).
   Leaving a flyer is not soliciting (but cannot contain advertising for sales); religious representatives are not considered soliciting.

<u>Fire Department</u>: Jaime Garrett gave the following updates:

- Fires on Tues. July 17<sup>th</sup> in downtown are (Darling/Saugstad areas)—joint investigation underway (police & fire) and patrols increased.
- Station #1—dedication Sat. Aug. 18<sup>th</sup>, 9-11 AM, all invited, dedication to Chief Green.
- Old Station #1 still in escrow.
- Fallen fire fighter from Placer County—services will be held at Bayside Church.

<u>Folsom Road</u>—Presentation from Dutch Brothers Coffee at August meeting—neighborhood controversy over project.

<u>Technology</u>—NA Banners distributed, Promote Me suggestions—roll, don't fold, clean with mild soap and water.

<u>Pleasant Grove</u>—Robert attended 2-hour fraud presentation, encouraged NAs to document everything to protect against fraud (felt RCONA procedures well documented), NAs handed out 43 new neighbor bags this month (City supplies getting low); picked up 4 Neighborhood Watch signs (\$80 check given to Sue tonight); MITP pizza sales proceeding—will coordinate with Stoneridge for next movie.

<u>WestPark</u>--Contacted developers to have repairs made to neighborhood monument and tiles; <u>City update</u> (per Scott): Roseville City officials are available to attend meetings 'for informational purposes only' for its proposed half-cent sales tax initiative [Measure B] placed on the November ballot. [RCONA/NAs cannot take position for or against initiatives.] Scott will be holding some community coffees.

Roseville Heights—Will hold NNO at Weber Park; helping with pizza sales at MITP.

<u>Cresthaven—NNO at Jack Wallace Park; Garage Sale following Sat. (Aug. 11<sup>th</sup>) 7AM-1PM; South Cirby—NNO @ Crestmont Park; Garage Sale Sat. Oct. 6th.</u>

<u>Stoneridge</u>—Had to cancel NNO—conflict with back-to-school night; may change to National Neighborhood Day (Sept. 16<sup>th</sup>—will contact Sue); will contact to have Measure B presentation. <u>Maidu</u>—NNO at Maidu Park, newsletter distributed.

<u>Cherry Glen/Theiles Manor</u>—Planning NNO with Folsom Road NA at Johnson Pool; Natasha Martin (Roseville Library) was guest speaker at last meeting; found newsletter volunteers while giving welcome bags; noted first year for K-8 schools early start to align with high school terms. <u>Fiddyment Farm</u>—Planning for NNDay with WestPark; Sutter Health presented this month—will move into Blue Oaks & Fiddyment Road building, open family medicine in early 2019, lab draws, no pharmacy or x-rays facilities. Will invite Measure B presentation for Oct. meeting; 6<sup>th</sup> high school to open 2020.

Woodcreek Oaks—Planning for NNO.

<u>Cirby Ranch</u>—Recruiting to replace 2 board members, elections in August (no July meeting); will move to quarterly meetings next year; will invite Placer Elder Protect for presentation [Sue attended event at Galleria and said event was very well staffed—lots of agencies represented]. <u>Sierra Vista</u>—Losing 2 board members, large 'rental' population unaware/not interested.

#### **Agenda Items & Committee Updates:**

<u>Library in Park</u>—Robert inquired if RCONA was going to have a booth at Mark White Park-Werner indicated this was probably the last one of the summer's program.

<u>"Hold Harmless Agreement"</u>—Werner presented RCONA's new wavier form (approved by insurance agent) to have vendors sign; sample given out and Sue will distribute copies to all board members, along with 'insurance incident' report forms (also previously distributed).

Meetings with "City/RCONA"—Jim said Mayor Rohan feels RCONA is a viable stakeholder in the Roseville community. Bob Velcheck will attend City Manager meeting (Aug. 15<sup>th</sup>); Jim wants someone to attend "Megan/RCONA" (Aug.9<sup>th</sup> 8:30 AM)—contact Jim if you can appear to discuss issues for your NA.

<u>Miscellaneous—April</u> mentioned 'cockroaches' at parks; Larry gave info of pest infestation at Cresthaven area; Sue expressed concern that City attention is needed to address the issue.

The meeting was adjourned at 8:20 PM.

"Meeting with Megan" – informal meeting notes

Present: Megan MacPherson, Werner Kuehn, Jim Kidd, Sue Hallahan-Cook, Christie Borchin (Stoneridge)

#### Informal meeting notes:

- 1. Send reminder to Megan—RCONA/City Manager meeting—Aug. 15<sup>th</sup> 10 AM; indications that Council attendees might be Bonnie Gore and John Allard along with Dominic and Megan. Robert Velcheck (Cirby Ranch) will be guest NA attendant. Werner will distribute agenda ahead. Jim mentioned potential RCONA proposal to submit letter to City Council—to recommend appointment of the 3<sup>rd</sup> runner-up candidate from the election be considered to fill Bonnie's vacancy instead of Council bringing someone else who had not run for the vacancy. Also mentioned was the City Charter and approaching process for suggesting changes.
- 2. Measure B—Megan indicated presentations to NAs can be scheduled through Megan (our contact) at mmacpherson@roseville.ca.us with a cc to Amy Ruiz at aruiz@roseville.ca.us. Megan and/or Dominic will be presenters. They would like to schedule as many as possible in September. Representatives present scheduled tentative dates with Megan and will confirm locations, equipment needs, etc. with Megan. Werner confirmed RCONA cannot take a position, presentations will be for 'informational purposes' only. If any NA invites presenters of 'Yes on 'B', they must also invite 'No on 'B' presenters as well. Christie asked if there was a 'Top 5 list' for the City's direction of goals/usage if the measure passes. Megan said the issues will be addressed at the Annual Council Goals Workshop to be held Sept. 4th at Maidu 6:30-8:30 PM. Discussions will address a 'what if it doesn't pass' scenario. Sue later inquired if there had been an alternative measure proposed to suggest just a quarter-cent raise, and Megan responded that it was not proposed because it would not have been enough for the long run. They also had considered a three-quarter cent raise, but decided to go with the half-cent raise proposal.
- 3. <u>Candidate's Forum</u>—Sept. 11<sup>th</sup> Randy Peters Event Center 6-8 PM. Werner said the four (4) known candidates who've announced their candidacy have been invited so far (Krista Bernasconi, Bruce Houdescheldt, Pauline Roccucci, and Stephanie Dement). The filing deadline was stated as tomorrow (Aug. 10<sup>th</sup>). Megan said only one candidate (Krista) has filed so far. Werner said he wants to have high school student involvement and will make those contacts. He's also going to check with William Jessup University and Sierra College for video participation (possible You Tube); Randy Peters venue has some of the equipment. Werner will send more info to Megan and coordinate on possible contacts.
- 4. <a href="NUSA">NUSA</a>—May 2019 Palm Springs—Werner wants more than one person to attend next year (New RCONA Procedure says RCONA will subsidize 2 attendees who must split the \$1200 total allowance and pay the rest themselves). Werner mentioned 'Neighborhood' Signs and potential beautification of gateway and freeway entrances to the City. Jim advised of past RCONA research for Neighborhood signs (procedure created but received no backing from the City so it was dropped). Megan suggested Werner bring the subject of "Community Identification and Beautification" up at the City Manager meeting next week.
- 5. <u>New NAs, Update RCONA structure</u>—Werner mentioned RCONA is planning for expansion to add new NAs from expanding and repurposed areas (HR Campus project mentioned in the

Industrial West plan—where will it fit now?). He went on to mention that RCONA is considering internal changes to its structure, fundraising and activities. He mentioned potential 'community partnerships'; Megan said she will notify her list of community teams from City agencies to share what can be incorporated with RCONA NAs. He also stated RCONA would like to be included in naming new areas to avoid future conflicts (Sue mentioned Sierra Vista Specific Plan being confused with Sierra Vista NA). Solaire was mentioned as already being contacted for activation of a new NA, and WestPark and Fiddyment Farm NAs will need to split again (approximately 8,000 homes already).

- 6. <u>RCONA meeting Liaison</u>—Megan has recent conflicts for 3<sup>rd</sup> Thursdays which might now prevent her from attending as City Liaison to the RCONA meetings. Megan will ask Brian Jacobson or Vonette Fontaine (has former City Manager office experience), to attend if she cannot.
- 7. Park Naming--Sue mentioned that she did not receive notices for the park naming this year, apparently went to former 'secretary' address from 2 years ago. She asked if we could be notified of what parks were to be considered for the naming process since many involve WRSP parks now. Megan will check to make sure City agencies send special City communications through her office to ensure they are going to the right updated contacts.
- 8. <u>School district/City Scheduling</u>—Christie asked whether there was any type of coordination of calendar scheduling between the City and School Districts because they sometimes cross main events of interest to families on the same days, such as 'Back to School Night' with National Night Out—Stoneridge NA cancelled its NNO upon learning of the conflict. Megan said it was a good suggestion and she would follow-up on the issue with the school districts.

A big Thank You to Megan for giving our members a special brief tour of the 'traffic division' room and other City Administration areas after the meeting.



NOTES: Red text indicates proposed changes. Lined out words, means it was deleted-

ARTICLE III - Neighborhood Association Membership

Section 2. Eligibility. The recognition criteria for Neighborhood Associations shall be as follows:

A. The Neighborhood Association is organized in a process of its choice with a leader and at least four (4) additional members. Neighborhood Associations must designate one of its NA Board members (at least eighteen (18) years of age) to be its representative to the RCONA NR Board.

<u>Section 5. Annual Certification</u>. Prior to the annual November nominations for officers, the <u>Neighborhood Organization Committee</u> RCONA Secretary shall certify to the RCONA NR Board that all Neighborhood Associations meet the criteria for recognition.

ARTICLE V - RCONA Executive Board

<u>Section 1. Members</u>. The RCONA Executive Board shall consist of the President, Vice-President, Secretary, Treasurer, and up to three Members-at-Large.

Any certified NA Board member is eligible to serve on the RCONA Executive Board, but no more than two members from the same NA may serve concurrently.

Exception: If an NA Board has married couple(s) serving only one spouse is eligible to serve on the RCONA Executive Board.

If two NA members from the same NA are elected to the RCONA Executive Board only one member can serve as an Executive, the other member must serve as a Member-at-Large.

The RCONA Board Neighborhood Representatives shall vote for a slate of Executive Board candidates to elect five (5) minimum to seven (7) maximum Executive Board members. Immediately following the RCONA NR Board meeting, the newly selected Executive Board members will meet to select their officers and Members-at-Large.

<u>Section 5. Order of Authority</u>. The President shall preside at meetings of the RCONA NR Board and shall be the Chief Administrative Officer of the RCONA NR Board.

The Vice-President shall, in the absence or incapacity of the President, exercise the power and duties of the President.

The Secretary shall, in the absence or incapacity of the President and the Vice-President, exercise the powers and duties of the President call the meeting to order and preside until the immediate election of a chairman pro tem.

The Treasurer shall, in the absence or incapacity of the President, Vice-President, and Secretary, exercise the power and duties of the President Secretary, calling the meeting to order and preside until the immediate election of a chairman pro tem.
