RCONA Executive Reports

<u>Approval of September 15, 2016 Minutes</u>: Hearing no objections or inquiries, the President ordered the minutes approved as submitted and placed on file.

Receipt of Treasurer's Report: Hearing no inquiries or objections, the President ordered the Treasurer's Report, dated January 1, 2016 to October 16, 2016, placed on file as submitted.

<u>Public Comment:</u> Werner presented his proposed 'doors' demonstration again and requested NAs to submit pictures of their activities. Sue Cook shared a notice that e-waste will no longer be accepted at the Utility Exploration Center. You can still take to the Materials Recovery Facility or call EUC for free pick-up (916-774-5780).

Guest Speakers:

Two members of the City of Roseville Parks, Recreation and Libraries Department—Dion Louthan, Director, and Tara Gee, Superintendent—provided a 45-minute presentation and Q&A discussions. They gave updates on current and proposed projects in the works. A full review will be available on the RCONA.org website.

Round Table proceeded with comments noted on the attached *RCONA Neighborhood News* newsletter.

A list of regular NA meeting schedules is posted on the RCONA.org website.

<u>City Report</u>: Sean Bigley gave the following updates:

- The City held its 2017/2018 "Goals" workshop overviewing revenue, expenses, Capital Projects, adjustments and future agendas. More 'goals' information is available on the City's website.
- Information for this year's Neighborhood Santa routes is scheduled to go online on Nov. 1st or 2nd. Please do not distribute anything further until then.

<u>Roseville Police</u>: Sgt. Bosworth announced the recent restructure for the police administration development programs. He will be moved to a new Social Services community program (homeless/parks/mental health/teens); Rob Baquera will return as RCONA's liaison, and Capt. Moore and/or other PD members may participate regularly.

Sgt. Bosworth announced several events:

- Drug Take Back—Sat.10/22 9AM-1PM and locations
- Tip A Cop—Sat. 10/22 11AM 3 PM at Red Robin; funds go to special Olympics
- RPAL Crab Feed—Sat. 12/3 tickets \$50 (more info to come)
- Woodcreek Golf Tournament—tomorrow Fri. 9:30 AM—volunteers needed, contact Sgt. Bosworth

He gave an update to the potential tobacco ordinance Officer Gary Cole had presented last month. The City Attorney has suggested that the issue might involve an entertainment ordinance, and they might want to hold off one-year to see what other cities may do as well. If we do receive feedback in the meantime, forward it to Sgt. Bosworth.

Captain Moore said Bridgette Dean, new Social Services Administrator, would like to make an introduction at the November RCONA meeting.

<u>Roseville Fire</u>: New PIO Jaime Garrett said she hopes to attend future NA meetings and gave the following updates:

- Placer County will test the Roseville alert system on Oct. 26th between 8:30 10 AM.
- There will be a 'fireworks' event coming up, and she'll send a warning so people won't think they're gunshots;
- Recent rains are helping with the large fires, but it's still wildfire season and we need to continue to remain cautious.
- Sat. Dec. 3rd—Fire Station #2 Open House, 10AM-Noon.
- Although they had lost their initial grant funding for their 'car seat installer', they have new people certified and will restart a new car seat program in the next month or so.

<u>RCONA Elections</u>: Secretary Sue Cook provided an official 'Certification' list of 16 NAs eligible as RCONA 'active' status to President Werner Kuehn and Vice-President Jim Kidd:

Maidu, South Cirby, Cirby Ranch, Cresthaven, Cherry Glen/Theiles Manor, Folsom Road, Sierra Vista, Roseville Heights, Los Cerritos, Woodcreek Oaks, Pleasant Grove, Highland Reserve, Stoneridge, Blue Oaks, WestPark, Fiddyment Farm. Two NAs could not be certified and had gone into inactive status via their own Presidents' requests [Meadow Oaks and Hillcrest]. Next, two NA Representatives volunteered for the Nominations Committee to contact all the active NA Reps to discuss their willingness to run for the 2017 RCONA Executive Board and report nominees at the November RCONA meeting (7 openings available):

Sue Cook's motion to appoint volunteers Jim Kidd and Doris Jones to act as this year's Nomination Committee was seconded and unanimously approved.

6:00- 8:30 PM shift: Andrea Hilderbrand and Julie DeCarlo; Loren & Sue Cook will pick-up equipment. [Nick Castle volunteered for 6-8:30 via email later.]

Sue Cook will deliver candy and SITP handouts to the storage facility for pick-up.

<u>Santa in the Park</u>: Sue Cook gave updates—please let us know if you have anyone who could help with the following:

- We need a roving photographer (take photos of artwork, entertainment, volunteers, crowd shots); Loren will be Santa's photographer.
- Werner checking on an audio technician (work local system for music, announcements, etc.)
- Handouts will be ready for Family Fun Night.
- We need food for volunteers' lunch—if anyone knows a business that might volunteer the lunch or portions, please advise quickly; we can supplement with Costco pizza/salads, etc. if needed.

- No train this year, but Sue checking with hayride for next year.
- Trying to find entertainment—if anyone knows a group that might be available (Sue's checking with 4 local dance groups, but nothing available so far).
- Schools have been notified for student volunteers; but please contact your NAs to get adult volunteers.

<u>Technology</u>: Loren Cook asked NA Reps to remind their website masters not to add outside programs to their website without Loren's approval first—it may be something that could be added for all the sites, but the biggest concern is security to the website; an action done by one of the NAs without authorization resulted in a recent crash to the RCONA sites.
