MEETING:

President Kuehn: Called meeting to order at 7:00 PM, Thursday, May 18, 2017

President called for comments/corrections to the minutes, hearing none, President Kuehn ordered the minutes approved and placed on file.

Treasures report Submitted by Treasurer Sue Cook was ordered placed on file pending year-end audit.

COMMUNITY UPDATE FOR ENGAGE ROSEVILLE:

Sue informed the Neighborhood Associations that the application for Engage Roseville was extended to 3:00 PM, Friday May, 26th, 2017. Scott Alvord posted for the community: Extending the date line will ensure ample time to cast the widest net possible for candidates. Scott stated, this is a very important committee and it is important to have representatives from all segments of the city.

INVEST HEALTH: City Council Member, Bonnie Gore and Shannon Quignon.

This Team will meet for a year to meet the goals for addressing health disparities and access to health services.

Roseville is one of 50 cities that received the Robert Wood Foundation Grant for the pilot project: INVEST HEALTH.

One of Roseville goals: Shannon has consistently stated we need sidewalk, and other services based on data in Theiles Manor, Roseville Heights and Cherry Glen. This is a prime example of how the disparities in service is addressed in mid-sized cities. The project will focus on building lasting relationships in mid-size cities, developing partnerships way past the two years of the grant.

The team will be investing in dialogue and building partnership with the two major hospitals in our community.

How we address systems and use data to drive the project:

The team will have focus groups, gathering ideas from the community members about what will make their life more comfortable. We have identified some communities which have no grocery store for

fruits and healthy foods but lots of alcohol and tobacco stores, we have parks that are not safe. One of the major questions we will have to answer: How is the community impacted if they don't feel safe?

The Robert Wood Johnson Pilot Project: INVEST HEALTH was funded in four (4) California cities: Two (2) in San Francisco, One (1) in Los Angeles and One (1) in Roseville. Las Vegas was also selected for the pilot project.

Program overview:

- a. Vision: what do you want to do?
- b. Build a strong case
- c. Who can make it happen
- d. Needed some early wins. Small gatherings at cirby elem school Saturday morning, giving healthy recipes and teaching financial skills
- e. Roseville Heights Neighborhood is dark how to create safety in the neighborhood, not enough lightning. Roseville Electric has funds to help the community. They will install LED light to shine on the streets. A community decision to add lights with Roseville electric in the fall starting with Theiles then Roseville Heights. This came about due to people networking in the neighborhood. If you want to be on the mailing list, Let Shannon and Bonnie know.
- f. Capital improvement funds will be looked at as an augment to the projects.
- g. The lighting involves changing out the fixtures first then put lights. During the investigation of fixtures out of compliance, 5000 fixtures will be adjusted.

SOLAR NET ENERGY MEETERING: ROSEVILLE ELECTRIC

Philip McAvoy: Roseville electric:

Roseville Solar: Philip McAvoy –Please reference this website: solar 2.0 website Roseville electric is green energy at this time.

The 2.0 will impact residents putting in solar after October 2018.

Cost base rates: assign cost to eligible customer

Fair and equitable policy: rates fairly match the rate to the customer. Assign cost when possible to the customer based on their class. High use and low use.

Roseville since 2000 has 10 million customers and has been ranked 9th for most installed solar per customers.

Over 6% of residential customers have solar.

Solar availability:

Solar is an excellent resource: 8760 hours in a year only 22% of the year solar customers are producing solar, the other time Roseville is producing solar power

California net energy metering has not reached it saturation level.

Solar customers receive services from the utility without paying for them at this time based on the NEM has not met its saturation level.

Non-solar and low-income customers subsidize NEM solar customer.

Roseville Electric reports Street light and traffic is not paid a fair share by solar customers.

Effective in 2018, Roseville will reach our 5% NEM cap.

Grandfathered in solar customers with agreements before 2018 will be compensated fully up to 20 years from the beginning of their agreement.

Roseville Electric is meeting with communities, during this period and will meet with City Council on July 5th, 2017.

ADMINISTRATIVE & COMMITTEE ITEMS:

Community First Bank: Treasurer Sue

Sue Cook restated the offer from Community 1st Bank which benefit RCONA's NAs-no fee accounts and other services including paper statements at no fee. During discussions, only one NA voiced an objection to switching banks. Concern was raised about moving accounts when they would be preparing for National Night Out, so the proposal was to allow for a final deadline of September 30, 2017 to complete the final transaction if the motion was approved. A quorum of 12 active NA's was present.

Jim Kidd's motion to move RCONA and subsidiary NA accounts to Community 1st Bank was seconded and approved (only 2 opposed).

Sue and Jim will contact the bank to see how quickly the move can proceed and notify all active NAs.

NA FLOATING EVENT/GRANT

Jim reported to the Associations we did not get the grant therefore we need to adjust our budget for this year. Recommendation for adjusting the budget: Suspending the floating subsidy of \$100.00.

Jim Kidd's motion to suspend our Floating Event (reimbursement up to \$100.00) was seconded and passed unanimously.

BYLAWS COMMITTEE:

Robert: Informed the NA that they will receive the changes to the bylaws to review and be ready to vote at the next meeting. The NA's will have received the 30days documents within the time line designated in the Bylaws.

NEIGHBORHOOD WATCH:

Updated procedure will be distributed to NAs; please discuss within your Neighborhood Association and be prepared to discuss and for possible vote at the next meeting.

VOLUNTEER HOUR TRACKING:

Sue has developed a tracking sheet that each NA may be using for tracking our volunteer hours, this will allow for uniformity throughout the organization.

Jim requested forming a grant committee: The committee will apply for grants, if you are interested, please contact, Jim, Sue or Werner.
