### **RCONA Executive Reports**

<u>Approval of June 15, 2017 Minutes</u>: Hearing no inquiries or objections, the President ordered the minutes of July 20, 2017, accepted and placed on file. June minutes were not received yet, will have to be submitted at the September meeting for approval.

**Receipt of Treasurer's Report**: Hearing no inquiries or objections, the President ordered the Treasurer's Report, dated January 1, 2017 to August 16, 2017, placed on file as submitted.

<u>Public Comment:</u> Werner Kuehn and Sean Bigley mentioned the Placer County Fairgrounds scoping meeting scheduled 8/29/2017 7PM at Riley Meeting Rooms at Mahany; discussions will be held re future plans for the property.

Jim Kidd mentioned that he, April and Robert Sanchez will host an RCONA booth for NA signups at the Galleria this Saturday 8/19/2017, 8AM-3PM near the Nordstrom entry on the first floor.

Bruce Houdesheldt of the Roseville Planning Commission said he was present to hear RCONA's topic on Planning Notices tonight. He said the next Planning Commission meeting will be 9/14/2017.

#### **Guest Speakers/ Presentation:**

#### Planning Notices

Jim Kidd indicated that he, and Loren and Sue Cook met with Greg Bitter and members of the Roseville Planning Department on 8/8/2017. Jim explained that the City is required to send project notices (filing, hearing, EIRs, etc.) only to homes/businesses within 300' of a project. As an additional courtesy and attempt to spread word further in the neighborhoods, has mailed some of its notices to the RCONA Neighborhood Associations for further distribution through the NA media sources. To try to facilitate the process, RCONA has been working towards a more automated method. The new plan is that Planning will send emails to Loren, he will post the notices on the RCONA website, and then send 'Planning alert' emails to the proper neighborhood(s) contacts; the NA contact can then find the notices on the website and further distribute the notices to its neighborhood through the NA media sources.

Loren Cook next demonstrated how to navigate the RCONA website and how to find the notices, and take further action needed. He would like each NA to send him a designated media contact to send the 'Planning alerts' to. Loren then showed more features of the website and connections like "how to locate an NA", crime mapping, schedule of NA meetings, etc. He also discussed a new feature called "Clubs" where each of the NA websites would be run through the RCONA website (he'd only have to maintain one website instead of 17 or so). Clubs does not require Word Press or any special programming skills, works basically like Facebook and Nextdoor, and actually has direct connection to other media. He said it's a great way to get sign-ups and build your email list; members would have to use a password to sign-up.

<u>Mid-Year Budget Review</u>: Werner announced that Sue Cook had distributed a mid-year budget review that reflected RCONA's present and projected finances for this year in comparison to the adopted 2017 budget. He indicated that, due to the failure of two of our sponsors to meet commitments, and denial of our grant application, our income fell short of hoped-for expectations. Jim Kidd introduced Robert Velcheck's suggestion that we replace the NNO and Floating Event reimbursements of \$100 each, and just provide reimbursement for one 'NA Support' event per year. Robert said it would be basically the same as the Floating Event,

only awarded for one event per year, and the NA could choose what that event would be—NNO or some other event that the NA might feel would be more beneficial to itself--such as a neighborhood clean-up. Sue Cook reminded that we've had to suspend the Floating Events the past two years when we didn't receive grant funding. Jim also announced that we were just notified that this would be the last year the City would provide its yearly budgeted 'RCONA Administrative Award' (currently \$1500, previously \$1000 per year). Jim said we need to concentrate on getting new members for the Fundraising Committee (Robert Sanchez has volunteered as the new chairperson)—please contact and submit your ideas to Robert. Sue will develop the new proposed procedure (basically a combination of the NNO and Floating Event procedures) and distribute it out for preliminary review and discussions for the September meeting, and then for NA discussions and potential vote at the October RCONA meeting.

**Round Table** proceeded with comments noted on the attached *RCONA Neighborhood News* newsletter.

Roseville Police: Rob Baquera announced the following:

- New Police Chief James Maccoun was sworn-in today.
- Ongoing issues of thefts from cars and homes where garage doors were being left open.
- Police Department is changing their shift schedule to try to improve coverage provided.
- Please confirm meeting schedules and let them know if cancelling or changing meetings.
- Sue asked please notify her if the NA is considering changing its meeting dates/times so she can check the meeting list—PD and Fire can only cover one meeting per beat/station at a time; Rob said avoid any more Tuesday settings—already filled for coverage.

### Roseville Fire: Jaime Garrett gave updates:

- She warned about solar eclipse glasses that have been recalled (Amazon was one mentioned); she warned that only approved solar glasses should be used to prevent damage to the eyes.
- Fire Station #1 has walls going up, it's proceeding well.
- They have hired 8 new fire fighters to begin the academy as of Monday 8/28/2017.

<u>City Report</u>: Sean Bigley announced that the City has started planning for this year's Neighborhood Santa. They will use the 2016 routes as the baseline and modify with updated demographics to determine 8 routes for this year. NAs should provide info for stops/slowdowns during the route to one central RCONA designee (RCONA will advise further; no direct contact with the City this year). They will send out final route selections in October so NAs can proceed with planning and post them in their newsletters and media. Sean will send a copy out of the 2016 routes for NAs to review. If you feel your NA should be considered (provide proposed route info), or if you wish to opt out for the route through your NA this year, please send an official notice from your NA Board.

### **Agenda Items & Committee Updates**

Werner announced that RCONA will be recognized for its 20<sup>th</sup> anniversary at the Oct. 16<sup>th</sup> City Council meeting; Werner will give State of the Neighborhoods address.

Werner indicated that Sean and Megan had suggested potential guest speakers—Dist. 4 Senator Jim Nielsen and Assemblyman Kevin Kiley. Werner said they would not be political presentations, just general introductions into what our representatives' duties entail—sort of Meet your Representatives (no political agendas).
