 - Wrap around services



What is Elder Abuse?

- Elder Statutes Apply to...
 —Elder Adults 65+ at time of crime
- Elder Abuse is...
 - -Physical
 - -Financial
 - -Neglect

Case Example



Eleanor

- 82 year old required her son to provide care
 - Transportation
 - Dressed & shower
 - Grocery shopping & medication
- When she confronted him about stealing from her bank account he brutally assaults her
- Son is arrested
- Victim is without a caregiver




Law Enforcement

- Arrest Defendant
- Emergency Protective Order
- File case with DA's office
- Review for charging

Criminal Prosecution

- Criminal Charges
 - -File a case
 - -Protective order
- Victim Advocate
 - -Service
 - -Civil restraining order
 - -Restitution
 - -Sentencing

Case Example



Eleanor

- APS help protect her finances & arrange for another caregiver
- Victim advocate found a locksmith
- Seniors First provided meals & transportation
- Senior Peer Counseling provided services
- District Attorney's Office filed charges & obtained a protective order



What about cases without a crime?

PROTECT team can still get involved



Ernie

- Elderly man with dementia found wondering the streets
- At hospital
 - Confused
 - Can't identify himself
 - Doesn't want to eat
 - Upset physically
 - Assaults a nurse





Ernie

- Law Enforcement identify the senior
 - 93 year old Veteran living out of a truck
- APS find appropriate housing
- Veteran's Services medical care, medication, housing
- Placer County Chaplaincy to sit, talk, and pray with him.
- Public Guardian determine if family is protective, seek conservatorship
