RCONA Executive Reports

Approval of February 2021 Minutes: Hearing no inquiries or objections, the President ordered the minutes of the February 2021 meeting accepted and placed on file.

Receipt of Treasurer's Report: Main account \$27,364.67, Scholarship- \$3,408.06, Trust -\$1.00

Public Comment: NONE

Lt. Jeff Kool Police Update:

- January- March have surpassed 100 thefts. 1 in 3 are Catalytic Converter thefts. There is a safety device you can have a muffler shop add which is a rebar or a plate. Older vehicles are targeted.
- Violent crime is up 30%
- Robberies are up 39% majority is retail theft.
- Burglaries down 14%.
- As summer approaches continue to be diligent and close your garage door and lock your doors AND windows at night.
- Stolen Vehicles are up 33%.
- Have a new license plate reader system called Flock and have tripled the amount of readers in the city.

Motion made to approve \$300 discretionary funds in the budget for appreciation gifts by Kevin. 11 NA's voted 6 NA's were not present VOTE 11-yes 0- NO. Motion carries.

Scholarship Committee Report: 7 applicants and committee is currently reviewing

Neighborhood Spotlight Presentation Sierra Vista: Ellen Debach- Riley gave presentation. NA has been active with RCONA since 2014, currently connect with 100 residents. Neighborhood promotes safety, preserves their neighborhood history and likes to build relationships. Ways they communicate Facebook, NA Website, Nextdoor Neighbor which has 485 residents active, also communicates via fliers.

City Update Brian Jacobson:

- City buildings will open up on Monday March 22nd with limited services.
- Program called Emergency Rental Assistance will begin March 22nd, city has \$5 million to help renters pay rent and utilities. Residents can apply at renthelpplacer.com.
- Residents inquiring about the loud booms in west Roseville, city said they are air cannons farmers use to chase off geese.
- Rate adjustment workshop will be on April 13th, for residents that want to attend they are asking you to register on the city website ,workshop time was not mentioned.

Roseville Fire Jamie Garrett: Administration office opening back up week of March 22nd ,_while firehouses remain closed to the public due to covid. Fire department is encouraging residents to get vaccinated.

Maidu: 21st annual garage sale April 24th. Had city representatives out to discuss the parks and they are requesting a BMX bike area. Also mentioned possibly a outdoor exercise area.

WestPark: Drive through coffee kiosk coming to Fiddymment and Pleasant Grove in 2023. Mojo opening in July and other commercial coming soon. Hayden parkway bridge opening ribbon cutting Monday, March 22nd at 4:00pm.

Folsom Road: Just held annual Board member election. Jeff is now president, Kumi- vice president

Kaseberg: Would like preserve their neighborhood. Also concerned with the construction on Washington- it's getting a lot of traffic coming into the neighborhood._Has had a lot of converter thefts.

Los Cerritos: Chief Bergstrom and Invest health attended their last meeting. Would like to get Neighborhood watch signs and lights for Weber Park, looking into a private security monitoring the NA. Guest from North Fiddymment neighborhood- Trevor introduced himself and mentioned wanting to split his neighborhood from Fiddymment Farm and forming their own NA. Has been reaching out to other residents in his neighborhood and sharing their concerns about development happening in their area.
